



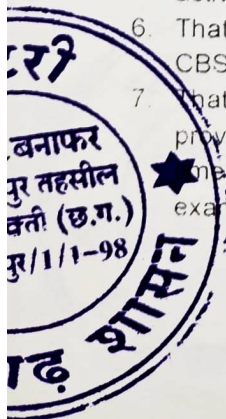

AFFIDAVIT

1. KASHI RAM CHANDRA Son of Shri MAHETTAR LAL CHANDRA, age 52 years, President of the CHHAIHAN SIKSHAN SAMITI, JAIJAIPUR (Name of the Society under section 25) running the SANSKAR CETRAL SCHOOL, NANDELI JAIJAIPUR (Name of the School) do hereby solemnly affirm and sincerely state as follows:

1. That CHHAIHAN SIKSHAN SAMITI, JAIJAIPUR (Name of the Society under section 25) is a registered Society under the Chhattisgarh Society Registration act of 1973, No. 44/1973 (Act under which Society is registered).
2. That the CHHAIHAN SIKSHAN SAMITI, JAIJAIPUR (Name of the Society under section 25) is of Non-Proprietary Character.
3. That the school is run as a community service and not as a business and that commercialization does not take place in the school in any shape whatsoever.
4. That no part of income from the institution shall be diverted to any individual in the Trust/Society/Company registered under section 25 of the companies act, 1956 School Management Committee or to any other person. The savings, if any, after meeting the recurring and non-recurring expenditure and contributions to developmental, depreciation and contingency funds may be further utilized for promoting the school and extending the cause of education in the same school only.
5. That school is not paying any charges towards using name, motto, logo or any other non-academic activities to any other institution, organization or body organization.
6. That the school will not open classes under CBSE pattern particularly class IX/X and will not use CBSE name in any manner without obtaining affiliation.
7. That the principal and correspondent/manager of the school have individually gone through the provisions content in the affiliation and examination bye laws, and the circular issued by the board from time to time. The school undertakes to abide by the provisions contained in the affiliation and examination bye laws, directions issued from time to time and the law of the land.

- 8 That the school will ensure compliance of all statutory requirements like EPF, ESI and Labour laws etc with respect to the school and staff of the school.
- 9 That the school will ensure that the building safety, fire safety, health and Hygiene certificates are being issued or renewed by the concerned municipal or state authorities from time to time as per the prescribed term.
- 10 That the school will ensure that all required infrastructure is available with the school before starting classes.
- 11 That the school will follow ensure that sufficient no. of qualified teachers as per the provisions contains in affiliation bye-laws are available with school before starting the class.
- 12 That the school will follow the provisions related to fee contains in affiliation bye laws and will disclose the details of fee to the students/parents every year before start of session without resorting to any hidden charges in the heads of the fee.
- 13 That the school will not coerce any student/parents to buy books/stationary/uniform from any particular shop.
- 14 That the school shall strive to make efforts for conservation of environment.
- 15 That the school will ensure that the school fulfil all essential requirements before applying for affiliation and will fulfil all other conditions post affiliation and comply with all the general rules as given in the affiliation bye laws or notified from time to time.
- 16 That incase affiliation has been with certain condition the school will not start CBSE pattern classes without submitting a certificate slash affidavit to the effect that the school has complied with all condition imposed by the CBSE and post affiliation conditions contains in affiliation bye laws along with general rules.
- 17 That state pattern classes IX to X running prior to the CBSE affiliation would be sponsored for the state board examination. State pattern classes IX to X will be closed in a phased manner no admission will be taken in the state board pattern class IX to X after getting affiliation from CBSE. The state board school will be discontinued after switched over to CBSE.
